

Modification of Contract
between
Brevard Workforce Development Board, Inc.
and
Herc Rentals, Inc.

This Modification Number 1 of Contract, hereinafter referred to as **Modification**, is made effective and provided by and between **Brevard Workforce Development Board, Inc. d/b/a CareerSource Brevard** hereinafter referred to as **CSB or CareerSource Brevard**, and **Herc Rentals, Inc.**, hereinafter referred to as the **Contractor**.

CSB and the Contractor entered into a contractual agreement effective July 1, 2020, hereinafter referred to as the Contract in this Modification, for the purpose of providing short-term and/or long-term leasing options of heavy equipment on an as-needed basis and in support of CSB's emergency and/or disaster-related projects. This Modification is effective November 1, 2020, regardless of the date of signing.

CSB has determined the statewide contract as most beneficial to operate under as the contract allows for more cost-effective pricing, increases the variety of inventory available for leasing, and allows for the rental of specific vehicles to quickly fulfill the project needs.

**Both parties agree to the following Modification applied to
Contract No. CSB19-502-003 and Modification 1 dated November 1, 2020**

1. Section 1, Terms of the Agreement is hereby modified as follows:

The parties hereto agree that effective November 1, 2020, in lieu of operating under Contract No. CSB19-502-003, CSB shall adopt the statewide Alternate Source Contract titled "Industrial Equipment and Tool Rental", Contract No. 518-410-19-ACS" awarded to Herc Rentals, Inc., and issued by the State of Florida Department of Management Services, expiring on November 1, 2023. The cost of rentals using the State of Florida Department of Management Services reduces the costs and expands available inventory necessary to meeting CSB needs. All other terms of the original agreement remain in effect.

Should the statewide contract become void or non-renewable, both parties agree to return to operating under the local contract, Contract No. CSB19-502-003, through the expiration of the terms initially set, expiring on July 1, 2024.


Agreement
