

**MODIFICATION OF CONTRACT**

between

**BREVARD WORKFORCE DEVELOPMENT BOARD, INC.  
d/b/a CareerSource Brevard**

and

**QUALITY LABOR MANAGEMENT, LLC & AFFILIATED COMPANIES**

This Modification Number 3 of Contract, hereinafter referred to as **Modification**, is made effective and provided by and between **Brevard Workforce Development Board, Inc. d/b/a CareerSource Brevard** hereinafter referred to as "**CSB**" or "**CareerSource Brevard**," and **Quality Labor Management, LLC**, hereinafter referred to as the "**Contractor**."

CSB and the Contractor entered into a contractual agreement effective October 1, 2019, hereinafter referred to as the Contract in this Modification, to provide a broad range of staffing services on an as-needed basis. Modification Number 1 was executed on January 16, 2020, with a subsequent Modification (Number 2) executed on September 16, 2020. Modification Number 3 became effective October 1, 2021. This Modification Number 4 is written and signed to exercise the Option 3 Period to extend the term of the contract. All conditions of the Base Year Contract remain as-is unless addressed in Modification 1-4.

**Both parties agree to the following Modification 4 applied to  
Contract No. CSB19-500-002 dated October 1, 2022:**

1. The term of this Contract is hereby extended to September 30, 2023, subject to available funding and performance remaining acceptable to CSB during this period.
2. This Modification is effective October 1, 2022, regardless of the date of signatures. All other Terms and Conditions remain unchanged.
